ANNUAL PASS Holder Purchase Agreement

In consideration of the purchase of an ANNUAL PASS at Lazy Springs Recreation Park, I/we agree to abide by the Recreation Park Policies, Rules, and Regulations including, but not limited to the following:

- ANNUAL PASSES are not valid for admission to certain special events, in conjunction with group rates, or when Lazy Springs Recreation Park is sold out for a group function.
- Report lost or stolen cards immediately to Lazy Springs Recreation Park.
- **Replacement fee for lost or stolen ANNUAL PASSES is \$5.00 each.**
- Use of the premises and facilities at Lazy Springs Recreation Park shall be at the sole risk of the passholder(s). I/we agree to indemnify, defend and hold harmless Lazy Springs Recreation Park, it's agents and employees from and against any and all claims, suites, losses, damages, injuries or expenses arising out of any injury, loss or damage to any person or property resulting from any cause whatsoever while upon the premises of Lazy Springs Recreation Park.

Violation of park rules and regulations, or misuse of your ANNUAL PASS, may result in your eviction from Lazy Springs Recreation Park or revocation of your pass based upon the management's discretion, subject to no refund policy.
